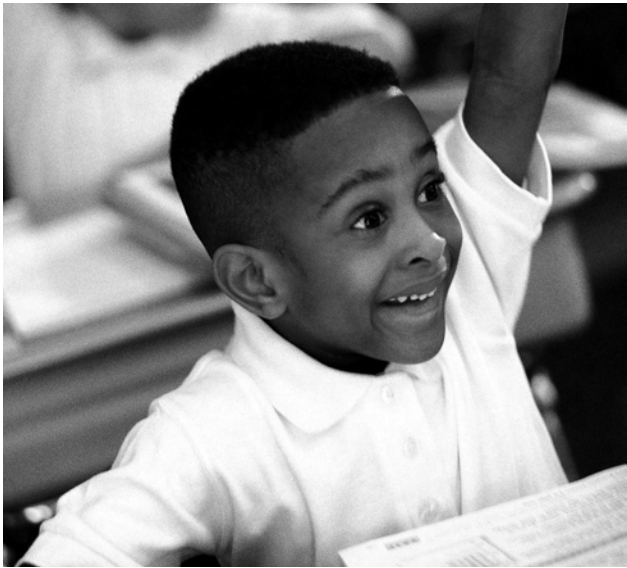

A Message from the 2007-2008 Governing Board President

Dear Members and Friends of Episcopal Schools,

The year just concluded was a year of new leadership, new programs, and continued strong service to members. It is my privilege and my joy to be able to report to you on that experience and to introduce this publication.

The academic year 2007-2008 was Dan Heischman's first as executive director of NAES. As none who have been members of the Association and who know Dan will be surprised to learn, the year did not feel, to the members of the Governing Board, like the first year with a new executive director. Dan's natural gifts along with his considerable experience and knowledge of the work of the Association allowed him to move into his new leadership role smoothly. The usual transition issues were almost completely absent!

Despite the omnipresent news coverage of our difficult economy, and the reality for our schools and the Association, NAES was able to finish the year with a surplus permitting an addition to the reserve fund. The members of the board are grateful for the loyalty of member schools during this difficult period and to the staff for excellent budget discipline.

I hope all of our members have had a chance to spend some time exploring the new NAES website which was opened to us on July 1, 2007. Considerable talent and a determination to achieve ease of use and a high level of service combined to create a site that serves us and you well.

Added to the usual annual array of services, programs, area and school visits, and workshops was the new Heads' Retreat, a day and a half spiritual retreat. First year attendance was good and the evaluations ensure that the event will be offered on a regular basis going forward.

The Governing Board expressed their gratitude and offered a fond farewell to two wonderful board members at the conclusion of the 2007-2008 year. Judith W. Lineback, Esq. of Greenville, SC,

and Miguel J. Brito, head of school at St. Philip's Academy, Newark, NJ, served long and well on the NAES board. Judy's leadership was essential in developing a planned giving program, and in establishing an endowment for NAES. Miguel's perspective from an urban school experience added greatly to his significant contributions to our work. The January 2008 meeting of the NAES Governing Board at his school was profound in its impact on all who were present.

NAES is in the strongest overall position it has ever been—in every way strength can be measured. Membership is strong and stable. Gift support is generous. Financial planning and management is disciplined, focused, and tied directly to the Association's *Strategic Plan 2006*. Services and programs are constantly and carefully reviewed and evaluated to ensure that the membership is well served. Perhaps most importantly, the Association is blessed with exceptional leadership. We are blessed with exceptional professional leadership in the person of Dan Heischman. The Governing Board of the Association is blessed with exceptional volunteer leadership in the person of my good friend Roger Ferlo, who became president of the Board on July 1, 2008. Executive Director's Report

Dear Members and Friends of Episcopal Schools,

Wherever I travel in this country, I have the great privilege of talking about the vitality and growth of Episcopal schools. We are truly one of the bright spots in the ministry of the church and one the liveliest and most hopeful signs in the Episcopal world.

Through your support, we have been able to expand our programs during a time of economic uncertainty and concern about enrollment in so many of our schools. Such difficult times necessitate careful consideration of how best to be of help to our membership. Website offerings have expanded greatly, as have the number of Outreach Grants we awarded this past year. Our staff—and we are blessed to have people working for this association that feel a personal commitment and a sense of stewardship toward the mission of NAES—has been vigilant in keeping our operating costs to a minimum. Likewise, a good amount of our time spent in consulting and visiting schools is given over to working with those institutions that could not otherwise afford our services. Your generosity, through such venues as membership and the Annual Fund, allow us to carry on the important work of this association and bring our experience and perspective to the widest possible variety of schools.

As we approach Biennial time, and come together to celebrate the collective ministry of Episcopal schools, we give thanks for the loyal and enthusiastic support we have received from individuals as well as school communities. You have both honored us and enabled us to carry forward with the good news of Episcopal schools. We will work hard to be worthy of this wonderful show of confidence in what we do. One can never say thank you enough, and we hope, in the pages of this Annual Report, to express that gratitude in yet one more way.

Episcopal Identity

At the root of every Episcopal school is its Episcopal identity. At the root of NAES' activities is support and nurture of Episcopal identity. What are the principal qualities that define Episcopal identity?



What processes does a school use for their discernment? What are the roles and responsibilities of school and church leaders in upholding Episcopal identity? How is Episcopal identity incarnate in the daily school life? The answers to these questions are the context in which our schools move and have their being. For NAES the question is how does this conference, website resource, *Network* article, or service support school leaders in this arena? It is with this last question clearly in mind that NAES goes about its mission and ministry.

Leadership Development and Recruitment

Outstanding leadership development and recruitment are essential to the continuing vitality of Episcopal schools and their identity. NAES believes that one of its primary tasks, either alone or in partnership, is to provide programs and services to schools and their leaders in this area.

During this past year, NAES assisted Berkeley Divinity School at Yale with the development of its new School Ministry Colloquium. This program is designed to inform Master of Divinity degree students about school ministry as a career

path and to offer training in its particulars. We look forward to working with Berkeley in the future and to the expanding pool of ordained school leaders this program will develop.

As for leadership recruitment, the Careers section of the NAES website listed 143 job vacancies at member schools during the 2007-2008 year. This service is available to members free of charge as a membership benefit, and includes a complimentary set of mailing labels with which to send information about the position to other Episcopal schools. Members should not hesitate to contact our office to post their announcement. You may also use the submission form on our website.

The professional and spiritual development of current school leaders through partnerships with seminaries and other organizations and NAES' own conferences continue to be a high priority for the Association. I once again served as a visiting instructor for the Doctor of Ministry in Educational Leadership program at Virginia Theological Seminary in Alexandria, Virginia, and as the leader of the Summer Ethics Institute sponsored by the Council for Spiritual and Ethical Education (CSEE). The Association's own conferences during 2007-2008 included these events.

- **Early Childhood Education Program Leadership Day, November 5, 2007, at St. Chrysostom's Day School, Chicago, IL.** School governance, church/school relations and developmentally appropriate chapel practices were the focus of this event, the first such NAES gathering in the Chicago.
- **ChapToR 2008, February 8–10, 2008, in Metairie and New Orleans, LA.** Cosponsored by CSEE, this annual gathering for chaplains and teachers of religion focused this year on ministry in crisis situations and offered participants the chance to assist in rebuilding New Orleans through a community service project.
- **Heads Retreat 2008, February 26–27, 2008, at the House of the Redeemer, New York, NY.** New to the NAES conference menu, this retreat offered sitting heads of school spiritual reflection, prayer, and worship, and at least a few moments to step out of the day to day stresses of school leadership.

- **Leadership & Governance Institute 2008, April 7, 2008, at Virginia Theological Seminary, Alexandria, VA.** This program for heads of school, board members and, at parish schools, rectors and vestry members provided guidance and information on best practices for the title topics.

Consultation, Advice, Assistance, and Resources

As part of its service to Episcopal school leaders, NAES provides telephone, e-mail, and, when necessary, on site consultation, advice, and assistance on a variety of school identity, leadership, and governance topics. It continues to be one of NAES' most important activities. Laura Walker, senior associate consultant to NAES, performs the bulk of this work and in 2007-2008 she received 140 initial consultation contacts, many of which required additional follow-up exchanges. Of these initial contacts, 56, or 40%, had to do with some aspect of governance and church/school relations (e.g. shared expenses, by-laws, board composition). Other areas of advice included: "nuts and bolts" policy and operational issues (15.7%); Episcopal identity issues including worship, religious education, and chaplaincy (15%); leadership transitions (13.6%); school start-up and expansion (13.6%); and strategic planning (2.1%). NAES remains committed to this work and we encourage you to contact our office with your questions.

July 1, 2007 marked the debut of the redesigned NAES website to positive reviews. We are grateful for the feedback of all kinds and will continue to strive to make the site evermore useful by providing timely and easy to access resources. 2007-2008 also saw the conclusion of the project to convert to PDF files all *Network* resource articles published from August 1998 through June 2007. These are now available in the Library area in the Resources section of the website. And finally, in preparation for its July 2008 release, editorial and production work on *Cycle of Prayer for Episcopal Schools*, 2nd edition, by the Rev. Jack Smith, was completed.

A Ministry of Presence and Connection

With Episcopal schools spread across the United States and located in Episcopal Church dioceses outside the U.S.A., it is vital that NAES provide a ministry of presence to schools and their leaders, and opportunities for them to connect with one another. In my role as executive director, I visited



70 Episcopal schools in 2007-2008, preaching at the openings of school, graduations, and Episcopal Schools Celebrations; leading faculty and board retreats; and reminding all of their connection and shared ministry with the larger Episcopal education community beyond their own institutions.

This larger community of schools was held up in prayer during Episcopal Schools Celebration, the Association's annual, week-long recognition of the shared ministry of the over 1,000 Episcopal schools, Early Childhood Education programs, and school start-up committees. At school, church, and diocesan services throughout The Episcopal Church during the week of October 7-13, 2007, school leaders, faculty, students, and parents united in prayer and worship under the theme of "Let Your Light Shine" (Matthew 5:16).

As part of its ministry of connection, the Association co-hosted receptions and gatherings for Episcopal school leaders and friends during the course of the year:

- Episcopal Schools Reception, Episcopal High School, Alexandria, VA
- Episcopal Schools Reception, Saint Thomas Church and Choir School, New York, NY

It also sought to connect Episcopal schools and NAES to the wider church, education, and association worlds through partnerships and opportunities to tell the story of Episcopal schools. One example of these efforts was the NAES-facilitated meeting in January 2008 that brought together the Most Rev. Katharine Jefferts Schori, Presiding Bishop of The Episcopal Church and the members of the Episcopal Schools Urban Alliance within NAES. Another is the exhibit booth at the NAIS Annual Conference in New York City in February 2008. Enabling Mission

One purpose of the Association's Annual Fund is to distribute 10% of the campaign's goal to member schools and to regional and diocesan Episcopal schools organizations as Outreach Fund grants. 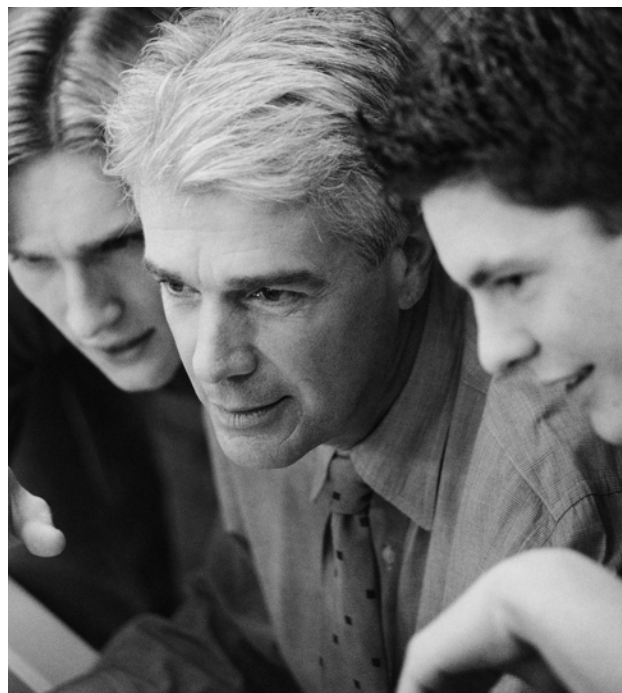

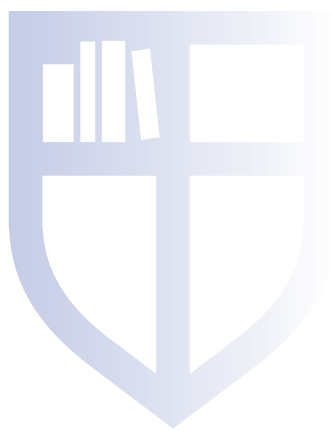
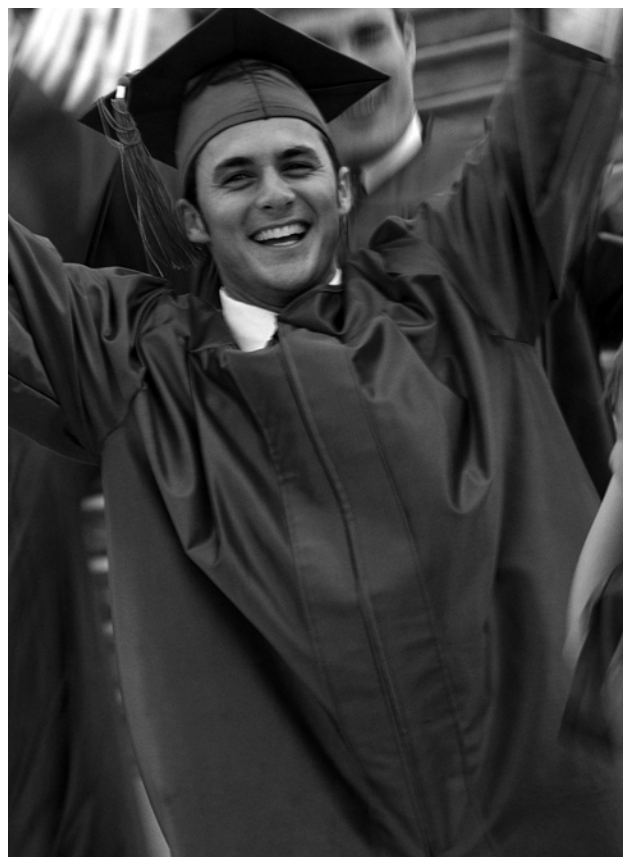

Financial Report

Dear Members and Friends,

As I end my sixth year as NAES Governing Board treasurer and begin my term as president, I am happy to report that the National Association of Episcopal Schools is in the strongest financial position in its history. Thanks to our strong membership and donor base, a financial plan directly tied to our strategic goals, and a disciplined spending model, NAES has ended the 2007-2008 fiscal year with a net revenue of \$89,281, exceeding our budgeted net revenue by approximately \$74,000. Dues revenue exceeded budgeted expectations this past year, with 462 schools and school start-up committees (5 of which were first-time members) joining the Association for the 2007-2008 year. Achieving our program and financial goals would be impossible without this strong membership support. Expenses were approximately 6% under budget due to cost savings and careful financial management by NAES staff. At the same time, we were able to introduce new conferences, publications, and enhanced member resources. The Association was audited by the IRS for the 2005-2006 fiscal year, and received a clean bill of health. Our fiscal management is professional, responsible, and sound.

As with many of our member institutions, additional fundraising proved something of a challenge this past year. Annual Fund revenue totaled \$106,670. Although this total is down significantly from last year, we are grateful that the Fund achieved the level it did, as many donors faced with financial challenges and a less stable economy were unable to give at the level of years past. For all who gave so generously this year, our deepest thanks. As part of its financial plan, NAES earmarks 10% of Annual Fund revenue in a given year for its Outreach Fund. Your contributions enable NAES to provide outreach grants to under served member schools, allowing us partially or fully to underwrite the cost of initiatives consonant with the Association's

mission. In 2008, NAES received a record number of outreach grant requests—up almost 400% over recent years. I am happy to report that our overall positive financial position for 2008 allowed us to supplement the mandated 10% earmark from the Annual Fund by granting a total of \$24,000 to 28 member programs, an equally record number.

Over the last seven years, NAES has been able to establish a significant financial reserve. As I indicated last year, building and maintaining a reserve fund is critically important to ensuring the future financial health of the Association. Such a fund provides a sound fiscal foundation for operations and programs, as well as providing a financial safety net protecting NAES in the face of unexpected disaster. In an act of prudent stewardship, the Governing Board this year approved a new investment policy, and established both short- and long-term reserve funds to take advantage of higher-return investment vehicles.

As we move into uncertain economic times, NAES is fortunate to find itself in a strong financial position. We are truly blessed and grateful to our member schools and generous donors for your leadership and continued support. Speaking personally, it has been an honor and privilege to serve as the Association treasurer these past six years, and in particular to work with such a talented and dedicated staff. I am especially grateful to Linda Glad, our Director of Operations, for her continued excellent work. Please join me in welcoming my able successor, Mr. Patrick Dickens, as he begins his first term as treasurer. And again, my deepest thanks to all of you—members, donors and friends—for your continued support for this Association, as together we strive to serve those who serve Episcopal schools.

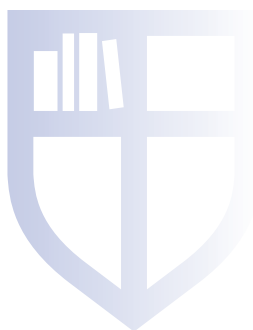
