# Governing Board President's Message

---

I am delighted to introduce this Annual Report on the work of NAES in 2008-2009. The report describes the many ways that NAES has worked to support our member schools in a challenging economic environment, serving those who serve Episcopal education.



Elsewhere in this publication, the Rev. Daniel Heischman, our executive director, will describe several new initiatives this past year, including new staffing, expansion of web and printed materials, and significant justice and equity initiatives.

It is no secret that 2008-2009 was a challenging year. But as president of the Governing Board, I am proud to join with Dan in reporting that from all accounts, our schools have not only worked creatively to weather the economic challenges of the past several months, but have also emerged from these storms with an even stronger sense of their mission and identity as Episcopal schools. This news is a tribute to the dedication and staying power of all those who lead and nurture these unique institutions.

The Governing Board continues its important work of strengthening the financial basis of the Association. This past year, the Board approved a formal investment policy for the stewardship of our reserves, and announced the establishment of an endowment fund, a first for the Association. At the same time, recognizing the financial strains experienced by so many of our schools, the Board significantly mitigated a scheduled dues increase for 2009-2010, and worked hard to find ways for schools to sustain their membership in what for many were straitened financial circumstances. It is testimony to the strength and reputation

of this Association that we received a \$50,000 matching grant from the E. E. Ford Foundation.

All new Board chairs are (or at least hope to be) grateful for the work of their predecessors. I want to take this opportunity to thank Dr. David Charlton, my predecessor, who with a sure hand both gentle and firm led this Board and this Association from strength to strength through a time of unprecedented growth and transition. I am deeply indebted as well to my distinguished colleagues on the Board, who serve our schools so selflessly and so well, and, of course, to the gifted leadership of Dan Heischman and his dedicated staff in New York.

I am also grateful for the hard work and gracious presence of the three Board members who retired: the Rev. James Lemler, priest-in-charge, Christ Church, Greenwich, Connecticut; the Rt. Rev. Robert W. Ihloff, retired Bishop of Maryland; and Merrily Dunlap, Commission on Schools, Diocese of Los Angeles. We also welcomed two new Board members in 2008-2009: Mary Ellen Christy, head of St. Chrysostom's Day School, Chicago, Illinois; and James B. Freeman, Ph.D., headmaster of TMI - The Episcopal School of Texas, San Antonio, Texas.

Last November, I had the great privilege of presiding for the first time at our Biennial in Tampa. More than 600 individuals attended Biennial, in spite of the difficult economic climate. The success of that event demonstrates how important these gatherings are to our common life as teachers and learners in Episcopal schools. Parker Palmer and Presiding Bishop Katherine Jefferts Schori gave superb and passionate presentations, addressing with grace the spiritual grounding that makes our work so important and so distinctive.

I look forward to another fruitful and exciting year for the Association, as we continue to serve those who serve our beloved Episcopal schools.

# Executive Director's Message

---

The past year has been an instructive one for all of us. There has been a sense, as one writer put it, of “lessons learned” as we have confronted, dealt with, and been shaped by an economic downturn. In our schools, we have learned that the future cannot be as predictable as we assumed it would be: once again, God has a way of doing surprising things with our “plans.” Strategic goals have been modified, capital campaigns put on hold, and what may have seemed to be somewhat routine tasks—such as getting contracts for the next academic year returned—is no longer routine. We have heard heart-wrenching stories from many of our families of economic hardship and necessary adjustments, hence so many schools have had to dig deep to help families going through very tough times. In turn, our schools have had to make very difficult choices, be it in cutting personnel, freezing salaries, or giving priority to one strategic goal at the expense of others.



In many cases, new things have been demanded of us, and I am moved by the dedication that our Episcopal school communities have displayed in showing compassion, making tough decisions, and holding to their basic institutional missions. The future may never be the same as we had assumed it would be, and uncertainty may be our companion for quite some time. Yet our schools have met the demands for the living of these days, and the courage, empathy, and the necessary adjustment of expectations and spending habits has not left us unchanged.

It comes as no surprise that the Episcopal identity of our schools has been an asset, not an impediment, in both making it through and

actually growing stronger as a result of what we have had to face. In difficult times, we fall back on our foundational understanding of ourselves, and that falling back is not so much a crutch as it is a springboard and source of inspiration for reflection, action, and care. We listened and responded to families in need because of the pastoral nature of our school communities; we held up those feeling the profound stresses of the economic upheaval in prayer because we are worshipping communities. We found the inspiration so needed to make the tough choices by virtue of our understanding that God makes moral demands of us and upholds us as we live through those moral challenges. Indeed, so many of our schools are actually stronger as Episcopal schools, per se, by virtue of the way in which they have drawn upon the traditions, practices, and values of the school.

In all that we have done as an association, be it in programming, our writing, our work with individual schools as well as giving a national voice to the state of our schools, our goal has been both to put words and stories to the difficult experience of the times while, at the same time, stressing the time-honored values and particular opportunities that Episcopal schools offer in times of crisis. Certainly difficult times call for extraordinary leadership, and the new components of our programming have been strong in stressing the unique role of an Episcopal school leader. So, too, difficult times require ample spiritual resources, and many of our programs—including our chaplains’ conference in New York and the heads retreat in Chicago spoke to the need for a deep internal life to meet the external demands of the day.

## **BIENNIAL CONFERENCE 2008: LAST OF ALL AND SERVANT OF ALL**

Despite the unfolding economic crisis in the fall of 2008, over 600 Episcopal school leaders and friends gathered for Biennial Conference

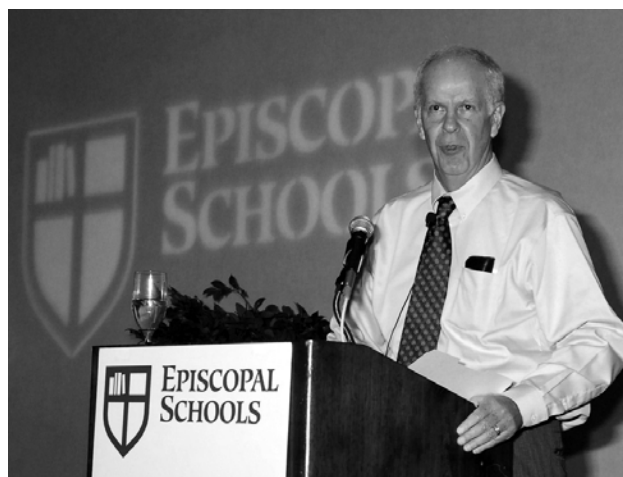
2008, November 6-8, 2008 in Tampa, Florida. Thank you to all who attended and presented! This gathering was a testament to the dedication of Episcopal school leaders and their commitment to their shared ministry.

“Last of All and Servant of All,” our theme, focused attendees’ attention on the vocation and servant-leadership aspect of school leadership and on increasing the diversity of the students and families our schools serve and the settings in which they do. Parker J. Palmer, Ph.D., the renowned education thinker, offered a series of plenary sessions and workshops on the former topic, while the Most Rev. Katharine Jefferts Schori, presiding bishop and primate of The Episcopal Church, took up the latter in her Opening Eucharist sermon. These addresses were in addition to a variety of workshops on Episcopal identity, school leadership, governance, and management, worship, religious studies, community service, and general pedagogical issues.

Also part of any Biennial is the recognition of Episcopal school leaders whose life and ministry have been outstanding and an inspiration to others. Gloria H. Snyder, the now-retired head of school at the Parish Episcopal School, Dallas, Texas received the Ruth Jenkins Award for outstanding service to Episcopal schools and NAES, while the Rev. Canon Thomas G. Clarke, retired headmaster of Campbell Hall (Episcopal), Studio City, California and a past president of the

#### ADVICE, ASSISTANCE, RESOURCES, AND SUPPORT

##### *Advice and Assistance*

NAES continues to provide advice and assistance on a variety of school identity, leadership, and governance topics to its member schools via telephone, e-mail, and, when necessary, on site consultation, six of which took place in 2008-2009. Laura Walker, senior associate consultant to NAES, performs the bulk of this work and in 2008-2009 she received 166 inquiries from 69 schools, their sponsoring organizations and dioceses. The number of inquiries represents a 18.6% increase over the 140 inquiries received in 2007-2008. Specific types of inquiries were:

##### *Resources*

While assistance is always just a telephone call or e-mail away, NAES is committed to expanding its offerings of print and Web-based materials for school leaders' use. To this end, Ann Mellow, former head of school at St. Luke's School, New York City, joined the NAES staff as assistant director for program development in September 2008. Over the course of 2008-2009, plans were laid for the redesign of *Network*, the NAES member newsletter, the Web site Library was revamped, gaps in Library resources were identified and plans developed to fill them, and The Commons, our sort-of-a-blog for members, was launched.

July 2008 saw the publication of *Cycle of Prayer for Episcopal Schools, Second Edition*, by the Rev. Jack Smith, retired chaplain at Groton School, Groton, Massachusetts. A complimentary copy was sent to each school joining NAES for the 2008-2009 year.

##### *Support — Outreach Fund Grants*

The Association annually aside up to 10% of Annual Fund contributions for distribution as Outreach Fund grants to member schools. #### NURTURING THE SOUL AND THE PROFESSION

In addition to Biennial Conference 2008, the Association offered a series of smaller conferences and retreats designed to strengthen the professional and spiritual lives of the participants.

#### *ChapToR 2009*

Cosponsored by the Council for Spiritual and Ethical Education (CSEE), 23 chaplains and teachers of religion gathered February 5-7, 2009 at the Desmond Tutu Center in New York City for recollection, discovery, reflection, and spiritual refreshment. David Streight of CSEE, the Rev. Paula Lawrence Wehmiller, Episcopal priest and retreat leader, and I facilitated the gathering.

#### *Heads' Retreat 2009*

Six heads of school joined the Rev. George E. Andrews II, Fran Scoble, and me at St. Chrysostom's Day School, Chicago, Illinois for an exploration of the progress of the soul and the authentic spiritual nature of headship. The event took place February 24 and 25.

#### *Leadership & Governance Institute 2009*

Held March 11, 2009 at the Cathedral Center of St. Paul in Los Angeles, California, 38 heads of school, rectors, trustees, and vestry members spent the day examining about church/school relations, Episcopal identity and leadership development. Serena Beeks of the Commission on Schools in the Diocese of Los Angeles, the

Rev. John Taylor, vicar of St. John's Episcopal Church and School, Rancho Santa Margarita, California, Laura Walker and I led the conference.

#### *Institute for Aspiring Heads 2009*

Houston, Texas was the site of this new addition to the NAES conference schedule held April 16-18, 2009 and partially under-written by the E. E. Ford Foundation. Connie Wootton of the Southwestern Association of Episcopal Schools, representatives of a variety of head of school search firms, and I led 18 individuals through discussions of the head search process, headship generally, and the unique aspects of Episcopal school headship.

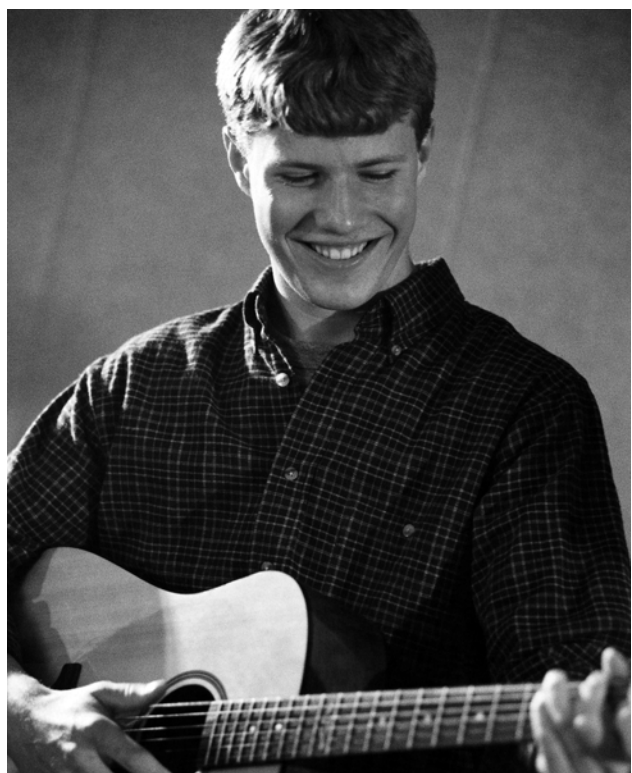

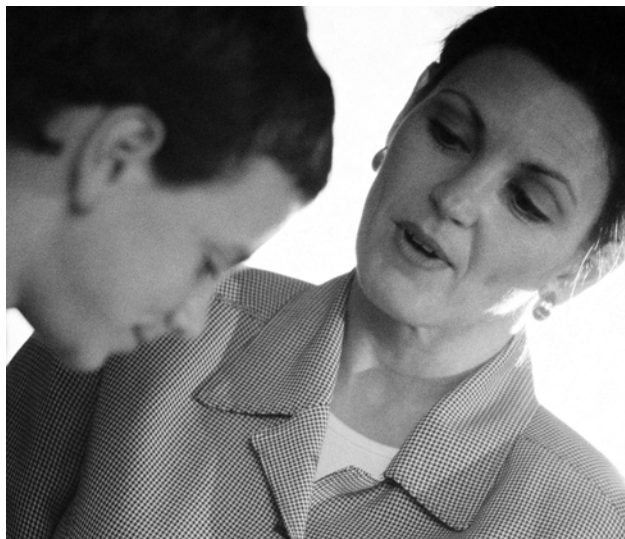

# Gifts to the Annual Fund

---

NAES remains most grateful to friends and supporters of the work we do through their additional contributions to the Annual Fund. The Annual Fund offers needed, additional support of Biennial Conferences, Leadership & Governance Institutes, annual chaplains conferences, NAES consulting services (both on-site and by telephone), and organization of the Episcopal Urban School Alliance. Importantly, 10% of the Fund is designated to provide Outreach Fund grants to member schools for particular projects. This direct source of funding enables NAES to accomplish essential work and significantly adds to the value of service and benefit of membership.



This year, contributions to the Annual Fund totaled \$97,590. This figure represents a 8.5% decline from 2007-2008 and continues at least a five-year, downward trend. (The annual fund raised \$149,785.90 in 2004-2005; \$134,550 in 2005-2006; \$136,710 in 2006-2007; and \$106,670 in 2007-2008.) The number of donors to the fund also declined by almost 30%—from 255 in 2007-2008 to 180 in 2008-2009. (In 2004-2005 there were 333 donors; 297 in 2005-2006; and 270 in 2007-2008.)

While we are concerned about the decline, and no doubt see it as a reflection of recent economic turmoil, the Advancement Committee is committed to seeking ways to rebuild our donor community and best communicate to the NAES constituency the necessity of supporting the organization with these additional dollars. Our capacity to offer needed services and small grants to worthy projects rests upon the income we generate through the generosity of individuals and schools. We extend our deepest gratitude to our Annual Fund donors for their support in this time of economic turmoil.

# Governing Board Treasurer's Message

---

It is with great enthusiasm that I write for the first time to the Episcopal schools community as the newly appointed Governing Board treasurer of the National Association of Episcopal Schools. As head of Ascension Episcopal School in Lafayette, Louisiana, I believe strongly in the mission and ministry of NAES, and am honored to serve as its treasurer.



I am delighted to report that the NAES remains in solid financial position. Thanks to the diligence of the NAES Governing Board and staff, the association ended the 2008-2009 year with a net income of \$59,587—a true accomplishment given the current economic climate. NAES membership increased slightly this year, with 465 membership schools spanning over 46 states and 5 countries. We thank our member schools for their strong commitment to NAES.

Gifts to the Annual Fund continued to be strong during 2008-2009 with a total of \$97,590 in donations. Ten percent of the Annual Fund revenue was disbursed to member programs in the form of Outreach grants. Eleven schools received grants this year for programs ranging in purpose, from developing community outreach programs to the expansion of leadership studies. We are grateful to donors for their stewardship, and look forward to reports from recipients on their progress.

A major achievement this year was the establishment of the NAES Endowment Fund in September, 2008. Gifts to the Endowment will help to ensure the financial future of many NAES programs, specifically those focusing on the development of leadership within our schools. NAES was also the recipient of a grant from the Edward E. Ford Foundation, a \$50,000 matching grant that will be used to support the Association's programs and services in the area of school leadership development. NAES quickly met its \$50,000 challenge through additional contributions in membership dues and increased giving from donors, and is scheduled to receive the grant in 2009-2010.

Program and administrative expenses were under budget by approximately \$104,000. Careful management and monitoring by NAES staff has enabled the Association to steadily build its reserve fund, which is critically important during challenging economic times. On the following three pages report the Association's statements of financial position, its statements of activities and changes in net assets, and its statements of cash flows for the 2008-2009 year.

As NAES continues to implement its strategic plan and looks toward the future, please know that your continued leadership, strength, and support is recognized and appreciated. Thank you for generosity and faith in our mission, as we serve those who serve Episcopal schools.
