The National Association of Episcopal Schools (NAES) is an independently incorporated, voluntary membership organization that supports, serves, and advocates for the vital work and ministry of those who serve nearly 1,200 Episcopal schools, early childhood education programs, and school establishment efforts throughout the Episcopal Church. Chartered in 1965, with historic roots dating to the 1930s, NAES is the only pre-collegiate educational association that is both national in scope and Episcopal in character.

The mission of NAES is to serve those who serve Episcopal schools. Within the Christian tradition of inclusion and open inquiry, NAES:

- **Affirms** the spiritual dimension of learning that values both faith and reason.
- **Creates and nurtures** an extended community of leaders in order to foster partnerships, unity, mutual support and professional growth.
- **Promotes** personal formation through moral, spiritual, intellectual, creative, physical and social development.
- **Assists** Episcopal schools in creating supportive communities through worship, learning, pastoral care and service.
- **Recognizes, appreciates and support**s the diversity within and among Episcopal schools.
- **Helps** schools explore, discover and articulate their visions and ministries as Episcopal schools.

Consonant with our mission and philosophy, we advance Episcopal education, strengthen Episcopal schools, and foster "excellence through association" by providing essential services, resources, conferences, and networking opportunities on

- **Episcopal School Identity** as expressed through school worship; religious studies and formation; service and service-learning; equity and justice; and school life and culture.
- **Leadership and Governance** matters pertaining to church-school relations and governance; leadership transition; school ministry recruitment, training, and deployment; and schoolestablishment, expansion, and planning.
- **Spiritual and Professional Development** of heads of schools, chaplains and teachers of religion, rectors, trustees and vectors, administrators, and teachers.



Executive Director's Message

You may recall that the theme of the 2012-2013 Episcopal Schools Celebration and Biennial Conference was "The Gift of Joy and Wonder in All Your Works". It is a phrase drawn from a prayer in the Book of Common Prayer baptismal service, expressing the hope for the future of those who had just been baptized. It has always touched a special cord within me, as the prayer reflects many of the hopes we have for all of our students in Episcopal schools, as well as a true sign of some of the blessings of our vocation. Indeed, Episcopal schools are not simply seats of academic learning, but are dwelling places of the Holy Spirit, where students discover that joy is our highest purpose and where wonder is celebrated.

All of us here at the National Association of Episcopal Schools (NAES) are privileged to serve our members as they realize the joy and wonder in their work. We are guided in our mission through our Strategic Plan and you will find this Annual Report ordered to reflect this. I would like to draw your particular attention to a few highlights of the year. Firstly, together, my colleague Ann Mellow (Associate Director) and I conducted over 900 hours of in person consulting with member schools. This is time for which we are especially grateful—even when we are called to assist in times of struggle—because we value the opportunity to connect at a deeper level with those we serve. Secondly, consistent with our effort to establish meaningful cooperation with the wider church and educational community, Ann and I—with the additional support of David Schnabel (Communications & Events Coordinator) have partnered with the Anglican Schools in Australia to produce a new religious studies curriculum. Thirdly, we are proud of the growth of the Episcopal Urban Schools Alliance (EUSA). This initiative truly shows how the Spirit can work through Episcopal schools to transcend boundaries and further the values of justice and equity in our churches and schools. I hope you have or will take the time to see our new series of videos on EUSA schools, accessible through our website.

We were pleased to welcome Sarah Badgerow to the team this year as Member Services Assistant. Sarah has come on board enthusiastically committed to advancing the work of NAES. I would also like to express a heart felt thank you to those members of our Governing Board who concluded their service this year—Hamilton Clark, Catherine Ford, and Connie Wootton. Their contribution cannot be underestimated and we look forward to the joy of their friendship for years to come. Finally, another word of thanks goes to all those who made a gift to NAES. Our aim is to be good stewards of your generosity and I hope that in the following report you find demonstrated the fruits of your support.

Our mission is to serve those who serve Episcopal schools. It is a true joy to work with a group of people in our schools who live out the mission of their respective institutions. It is a wonder to see their commitment and dedication. We are truly blessed.

MEMBER VALUE:

To enhance the value and benefits to current and future members by providing essential programs, services, information, and resources.

Executive Director Dan Heischman and Associate Director Ann Mellow conducted over 900 hours of on-campus consulting in the past year. They travelled across the country to be present for commencements and chapel and special worship services, as well as workshops for faculty, trustees, and parents. Whether on the phone or in person, Dan and Ann supported members on themes that unify us in our Episcopal identity.

Recurring topics of inquiry include:

- Church-School relations—in particular regarding governance roles, financial responsibilities, and establishing a shared vision of Episcopal Identity,
- The role of the Chaplain and appropriate compensation,
- Evaluation and compensation of a Head of School and how to navigate a leadership transition.

The ongoing series of free monthly webinars continue to serve as significant sources of learning for our members—reaching 316 unique logins. These virtual gatherings provide important professional development and informational opportunities to those schools that lack the resources—financial or personnel—to send their team to off-campus meetings. Giving emphasis to the unique assets NAES has to offer our membership, among our most popular topics were:

- Episcopal Identity and Faculty Recruitment
- An Interfaith Framework for Teaching World Religions
- Episcopal Identity: Discerning Who We Are
- Leadership Transitions: The Search Process
- Social Media: A Legal Primer for Schools
- Marketing Your School's Episcopal Identity

We continue to leverage online content—through the Library, the Commons blog, and News items—as well as our newsletter, *Network*, and Mid-Month Member Missive emails to provide current, relevant resources and interaction. Having passed 500 followers on Twitter and reaching upwards of 200 Facebook 'likes' each month, social media represents an ever-growing avenue of communication with our members.

LEADERSHIP AND GOVERNANCE:

Provide services that promote exemplary leadership and governance in Episcopal schools.

Providing "excellence through association," NAES meetings and Biennial Conferences equip Episcopal school leaders with the tools they need to live out their institutions' mission. Over the past year, 532 Heads of School, other administrative staff, and faculty participated in three formal professional development opportunities, including:

- Biennial Conference 2012 in Baltimore, Maryland, which featured workshops for new school heads and new chaplains
- Leaders for the Future Conference in Fort Lauderdale, Florida
- Behavioral Challenges in Early Childhood Education, Los Angeles, California

NAES has also gathered our members at informal receptions over the year to share fellowship and knowledge, including in Philadelphia, Los Angeles, and Chicago.

Our free monthly webinar series featured focused topics for Episcopal school leadership, including:

- The Healthy Church-School Financial Relationship
- Lay Pension Plans for Episcopal Schools
- Episcopal Schools: A Primer for Diocesan and Other Church Leaders
- Three Things Boards Should Be Doing
- Welcome to Episcopal School Headship & Welcome to Episcopal School Chaplaincy

At the Biennial Conference in Baltimore, NAES honored Merrily Dunlap with the presentation of the 10th Ruth Jenkins Award for "outstanding service to Episcopal schools and the Association." In her role as the inaugural executive director of the Commission on Schools of the Episcopal Diocese of Los Angeles, Mrs. Dunlap created procedures and protocols for the schools in the diocese; strengthened the relationships among the schools, parishes, and diocese; and served as a valued member of the diocesan staff.

NAES was also humbled to serve as a source of resources and point of contact for a community of support during the difficult and sad events that marked the 2012–2013 academic year. Hurricane Sandy, the Moore tornado, and the tragic violence of the Sandy Hook Elementary shootings and the bombing of the Boston Marathon brought a deeper understanding of the vital nature of the values embodied by Episcopal schools and our need to remain united in God's gift of hope.

ADVOCACY WITH THE WIDER CHURCH:

Advance the character, values, mission and ministry of Episcopal schools to the wider Church and educational community

In our service to those serving Episcopal schools, NAES is privileged to communicate the uniqueness of this ministry and method to the extended bodies of the Church and school communities. The cumulative knowledge of the Association's staff in both these realms enables us not only to navigate their complexities but also identify opportunities for collaboration and growth.

Over the past year, Dan and Ann have partnered enthusiastically with the Anglican Schools Commission of Western Australia to make their Religious Studies Curriculum pertinent and available to our members. During their travels to the country, Dan visited numerous Anglican schools and Ann represented NAES at a meeting of the Anglican' School's Association in Sydney.

Through his visits to Berkeley Divinity School at Yale and Episcopal Divinity School, Dan continued NAES' strong commitment to visit seminaries of the Episcopal Church to talk about the importance of and opportunities in school ministry.

NAES is committed to maintaining fruitful partnerships with affiliated agencies through participation in dialogue [the Episcopal Church, the US Department of Education, Council for American Private Education (CAPE)], representation at meetings [the New York State Association of Independent Schools (NYSAIS), Florida Council of

Independent Schools (FCIS)], co-sponsored events [the Center for Spiritual and Ethical Education (CSEE)], and mutual support [the Southwest Association of Episcopal Schools (SAES)].

Additionally, Dan's ongoing teaching through the Doctor of Ministry program at Virginia Theological Seminary is an important expression of the common vision of our organizations.

JUSTICE AND EQUITY:

Articulate a core religious identity within the context of our multi religious and inclusive Episcopal school communities by promoting values of justice, equity, service, civil discourse, and moral courage.

Each year, NAES allocates 10% of the budgeted Annual Fund goal or \$12,000 (whichever is greater) to providing mission relevant grants to our members. This year, \$46,000 was distributed through 12 Outreach Fund and seven Episcopal Urban School Alliance (EUSA) Grant programs.

Among the programming supported by these awards was:

Outreach Fund Grants

- Participation in Episcopal Schools Celebration,
- Attendance of the Biennial Conference in Baltimore,
- Support for partnership programs with Haiti,
- Faculty training, a summer outreach program and tuition subsidies to bridge access and learning gaps for low-income students.

EUSA Grants

- Faculty professional development in Responsive Classroom methodologies,
- Faculty participation in "Uncommon Impact's" Train-the-Trainer program,
- Support for the strategic planning process,
- Mission sustainability consultation and,
- Marketing and Outreach initiatives.

NAES is proud of the significant growth in the EUSA program over the past year. Working in coalition through NAES, these 10 participating schools amplify their impact to provide quality education to underserved, low income families. Each year, the leadership of EUSA gathers to share best practices and communion. Their 2012–2013 annual meeting was held in Baltimore in conjunction with the NAES Biennial Conference.

At the Biennial Conference in Baltimore, NAES honored the Rev. P. Roger Bowen with the 16th John D. Verdery Award for "outstanding service to Episcopal schools and the Association". Fr. Bowen is currently the principal liaison in the United States to the Episcopal Diocese of Haiti Partnership Program and a tireless champion and advocate for the 254 schools in that diocese.

Funds raised through the collection at the Biennial Conference Closing Worship were donated to Episcopal Relief and Development's Hurricane Sandy Relief fund.

STEWARDSHIP:

Ensure the financial sustainability of the organization.

NAES strives to model the convergence of mission excellence with sound financial management. The Governing Board oversees the maintenance of a minimum of one year's operating budget through a professionally advised investment portfolio. Under the skilled leadership of Director of Operations Linda Glad, NAES continues to enhance our programming while remaining within budget restrictions. Our annual audit was concluded with no management letter.

Our Annual Fund was a vibrant success, with 216 gifts totaling \$109,050.00. We are grateful to all of our supporters whose generosity ensures our ability to extend our reach throughout the community of Episcopal schools, without exclusion based upon income. The Annual Fund directly supports our members' work through our Outreach Fund grants.

We were honored to install 3 new members to our Muhlenberg Society for planned giving at our Biennial Conference in Baltimore. These friends ensure that, like the society's namesake William Augustus Muhlenberg (1796–1877), NAES will remain a positive influence in the field of education for generations to come.

The Corporate Subscription program offers an opportunity not only to cultivate professional collaborations with relevant school and church entities, but also to further diversify NAES's income streams. Over the past year, this program grew to 19 participants—an increase of 30%.

Any organization is only as strong as the individuals who serve it. In that spirit, NAES invests in the professional development of its staff. This year, Director of Operations Linda Glad, Communications & Events Coordinator David Schnabel, and Ann Mellow all attended meetings of the American Society of Association Executives (ASAE) or the Professional Convention Management Association (PCMA). Member Services Assistant Sarah E. Badgerow attended seminars on Major Donors and Foundations & Corporate Sponsorships conducted by the Center for Non-profit Leadership.
